C.	Poppy & Remembrance 1. The 2025 Poppy Campaign officially started on Friday Oct 31 at FarmBoy, Independent, Loblaws, Metro and Walmart. COSTCO will only have a presence on weekends by cadets due to their strict adherence to the COSTCO national policy. This resulted in all the volunteer shifts being cancelled, and not everyone able to find an empty shift at another store. 2. The coordination of empty shifts is severely hampered by being directly tied to the official paper version, and the lack of a volunteer willing to take on just the duties related to this type of coordination. 3. Traplines were delivered and many schools reached out early this year to ensure they received poppies and stickers, as well as participate in the Poster and Literary Contests. 4. Wreath requests have been received and the order for “extra-ordinary” deliveries to individuals and organizations not present for the Ceremony were submitted. Hopefully they arrive this week, as Carleton Lodge requested six, with special banner inscriptions. 5. The merchandise sales and wreath payments have been enhanced by Treasurer Will Read’s work to accept EFTs and with new buttons on the POS terminals at the bar. 6. The Bartenders’ Binder with a matrix for questions and payment processes was updated and is behind the bar for them to consult. 7. We are still missing a Guest Speaker for the Remembrance Dinner on Sat Nov 8, with no response received to date from the National Speakers’ Program. This is being followed up on.	

	8. Shane Box and the Principal at JMSS received Dave Cole, Paul Leadston and Kevin Brown for a quick coordination session on Fri Oct 31. The participation of the Grade 12, with Grade 11 watching to learn, will continue as in past years. They will also be having the grounds around the front and specifically by the monument tidied up. 9. A site reconnaissance was conducted on Sun Nov 2 by Parade Commander Stéphane Guy, MC Craig Jacob and Kevin Brown. There will be a marching band from 40 Falkland Sea Cadets, and marching contingents from 28 Fd Amb, 75 Sqn Barrhaven Air Cadets and other cadet units. 10. Cash counting is going well and the results are being updated and posted daily on the Bulletin Board. 11. The Tap2Pay devices are marginally louder this year (but still not loud enough) and still very sensitive to cellular signals. The multi-tap option of using CC or Debit cards to pay for merchandise is not particularly fast, and may become a source of lost revenue, which will be covered in the final accounting analysis.

M.	Technology Officer 1. The satellite orientation glitch is back with the bad weather, in spite of assurances that everything was fine on the roof and that software could fix the issue. Weather permitting, a proper check and tightening of the dish(es) with better alignment will be conducted.	

	2. The LoopTV experiment is no longer a “good fit” with the multitude of different sports being requested to be watched by patrons, and the lack of revenue that the system was originally intended to provide. Reviving or acquiring a fourth Bell Satellite device will be considered once the matter is properly discussed between the Treasurer (billing) and Bar Officer/Manager with tech support from Technology Officer. This would provide a 3rd screen to watch live events on. 3. The Rogers VOIP Business Telephone system has a lot of “line noise” that is compounded by the alert notification of voicemail messages. However, even when voicemails have been dealt with, there is still an abundance of static on the lines, so a Technical Support Work Ticket will be submitted to the Rogers’ Support system. There was some discussion about the VTech brand of cordless phones being at fault, but when a corded phone was used to test the system, the static was present while the voicemails were pending, although there was residual static after the lines were cleared of voicemails. This effectively narrowed the “culprit” to being the VOIP line instead of the physical devices.
