Poppy Chair Report

- The 6 retail stores in Barrhaven where we have a Store Stand have been having fluctuating degrees of success in terms of Legion Presence and general interest. COSTCO did not let us start until Nov 1st.
- 2. To date three "Calls for Volunteers" have been sent out, and other than no Cadets for the day shifts on the weekend of October 26/27, all stores have been open for at least two of the three daily shifts. Cadets were able to assist starting the weekend of Nov 02/03.
- 3. Merchandise for sale at the six stores has seen a steady flow of interest, with some new items this year doing really well, and some older items not as well. Poppy Centres have been in high demand, and so far we have managed to stay ahead of the ordering curve.
- 4. Once again in 2024 the Pay Tribute Boxes, also known as Tap2Pay, have been extremely sensitive to physical location and cellular connectivity, with seemingly random windows when they work well, others when only one or two sensors work, and sometimes they don't work at all. That said, they are still a significant source of donations. Verbal report on Donations to Date will be provided during the Executive Committee meeting.
- 5. The Poppy "Traplines" were set on October 25, and a few new stores have been added as they identify themselves. The schools have also shown interest in having the Poppy Stickers and donation boxes, with many new schools having been added to the existing lists.
- 6. Poppy Wreath orders have stabilized and the inventory is set for the Parade. Two stores requested theirs for display at their location, and these will be collected on Nov 10 to be at the Ceremony for their representatives to lay at the appropriate time.
- 7. The Cash-counting volunteers and Treasurer's Accounting Team have been busy with the donation boxes and wreath payments.
- 8. The Sergeant-at-Arms and I visited with Shane Box at John McCrae Secondary School for a coordination meeting and site reconnaissance on Fri Oct 25, and I participated in their preparations for the school's video presentation on Oct 30. During their Assembly, planned for 09:30 am on Nov 11, they will show a video in all classes because there are too many students to fit in their gymnasium. Following this, the Grade 11 and Grade 12 students will join us outside by the cenotaph.
- 9. Results from a final coordination meeting regarding the Parade and Cadet participation will be reported on verbally, if it took place before the Executive Committee meeting.
- 10. Verbal report to supplement Hospitality Chair regarding Remberance Dinner, since this report is being submitted early.

Technology Officer Report

- 1. Projects completed:
 - a. Rogers' voicemail and new branch telephones activated.
 - b. Issue with Security Alarm System identified and rectified, with cellular connectivity and a service increase of approximately \$12.00 / month.
 - c. POS buttons for new products (Legion merchandise and new beer) activated, old products deactivated.
- 2. Projects in Progress:
 - a. The Bell Modem device was sent back on Oct 21.
 - b. The quote for new Point-of-Sale hardware, software and services has been received. It will be analyzed in more detail after the Poppy Campaign wraps up. We are looking at approximately \$7,250.00 (before taxes) for new hardware and one year of system maintenance and cyber- security services. The recurring annual service fees are the portion that need to be better defined before presenting the business case.
- 3. Projects pending:
 - a. Testing of MS Teams with a view to support remote viewing (and potential interaction / participation) of General Meetings will begin mid-November.
 - b. Develop, test and implement Membership card-scanning (both plastic and digital) to accelerate the sign-in process for attendance during General Meetings. Beyond Member Name and Number, as required to confirm attendance in the current manual format, there will be no collection of additional personal information.
 - c. Some re-wiring / new wiring of the POS possible, especially if new hardware eventually installed.
 - d. Review of Camera Security System hardware and software not before December 2024.
